9. May Meeting Reports

a. Military Road Alliance meeting

Mr. Broome reported on the discussion at the Military Road Alliance about the legal basis for homeowners associations in Louisiana. An association is defined by it's governing documents, usually the Articles of Incorporation, By Laws and Covenants. Covenants, which are officially know as Building Restrictions, are a contract between each property owner and other property owners in that Phase. If a covenant is not enforced for two years it can be found tote abandoned but clear evidence must be provided to show this. Violation in one Phase do not violate covenants in another Phase. All this depends on circumstances.
